

Go For The Gold Lucky Draw - Terms and Conditions

1. Go For The Gold Lucky Draw ("Lucky Draw") is organised by AIA International Limited, a company incorporated under the laws of Bermuda with limited liability and acting through its Hong Kong branch ("AIA"). The campaign period is valid from 1 January 2026 at 9 a.m. to 28 Feb 2026 at 6 p.m. (Hong Kong Time) ("Campaign Period"). All submissions are subject to Hong Kong time and the timestamp recorded by AIA's server. By participating in the Lucky Draw, participants agree to these terms and conditions (the "Terms and Conditions").
2. To qualify for the Lucky Draw, participants must meet all of the following conditions listed under either Condition ONE or Condition TWO:

Condition ONE

- Participants must be registered users of the AIA+ mobile app and have linked at least one valid AIA life insurance policy to their AIA+ account;
- Participants must log in to the AIA+ mobile app and navigate to the Hot Picks campaign article titled "Go For The Gold Lucky Draw", click "Join Now", and successfully submit their entry within the Campaign Period. The article "Go For The Gold Lucky Draw" will only be visible to users whose AIA+ mobile app is linked to at least one valid AIA life insurance policy;

- Each phone number or email address of participants can only be used once for entry. Duplicate submissions will be considered invalid; and
- Participants must be physically present in Hong Kong or Macau when registering their AIA+ account.

OR

Condition TWO

- Participants must receive a unique 1-on-1 hyperlink to the iSay Lucky Draw article from an AIA Financial Planner, click "Join Now" of the Lucky Draw article and successfully submit their entry within the Campaign Period;
 - Participants information in the company database including name, phone number and/or email address, will be used for the purpose of administering the Lucky Draw;
 - Each phone number or email address of participants can only be used once for entry. Duplicate submissions will be considered invalid; and
 - Participants must be physically present in Hong Kong or Macau when receiving the Lucky Draw article and submitting the entry.
3. Participants who meet either Condition ONE or Condition TWO above will be entitled to one Lucky Draw chance per condition, with a maximum of two chances (one per condition) and are deemed to have accepted these Terms and Conditions.
