## Memo

At AIA, we always support our financial planners to leverage on social media platforms to extend their business opportunities in a compliant manner. We recently observed there are improper uses or comments on social media platforms by individual financial planners.

The Company would like to remind all agencies and financial planners that when you post, repost or comment on social media as financial planners or in your personal capacity, whether the content is public or not, it represents or is deemed to represent the AIA brand. This includes work-related posting as our financial planner; commenting on a topic related to AIA and the insurance industry; participating in any AIA-sponsored digital platform; soliciting business opportunities as a representative of AIA; identifying your connection or affiliation with AIA; or creating personal social media posts.

Financial planners should also refrain from posting or publishing any inappropriate content on social media or other communication platforms (e.g. content that contains bullying, hatred, violence, pornography, threats, or discrimination)

When you are using your social media platforms in the capacity as an AlA's financial planner:

- Comply with all applicable laws, rules and ethical regulations at all times
- Be truthful, accurate and respectful; should refrain from posting or publishing any inappropriate content on social media or other communication platforms (e.g. content that contains bullying, hatred, violence, pornography, threats, or discrimination), and always be careful when discussing sensitive topics that may result in receiving inflammatory remarks
- Protect and enhance the value of AIA's brand; use your best judgment to anticipate peoples' reaction on the comments / information your posted, including the potential adverse impact on AIA's brand
- Be conscious when mixing your business and personal lives. When you are online, your
  personal and business identity are likely to be perceived as the same person. Remember
  that you should not disclose any non-public information of AIA (including confidential
  information), and be aware that taking public positions online that are opposed to AIA's
  interests might cause conflicts
- Post accurate messages and exercise good judgment
- Never argue on social media platform

Financial planners should maintain their professional image, and strictly adhere to our "Social Media Policy and Guideline (For Agents)" when using social media. We also ask all financial planners to diligently manage and use their social media accounts. The company will appropriately handle all non-compliance cases by escalating them to the Market Conduct Committee (MCC) for deliberation. If substantiated, the Company shall impose penalties ranging from a written warning to termination of contract depending on the severity of the violation.

Financial planners can login to Agency Corner to read and understand the Company's "Social Media Policy and Guidelines (Agents)".
