AIA Vitality Member Benefit

Green Common e-Shop e-coupon is an active reward choice available to AIA Vitality members where Bronze, Silver and Gold members can enjoy HK\$30 e-coupon, and Platinum member can enjoy HK\$50 e-coupon*.

Reward Credits

- You can earn up to 2 reward credits each calendar month, depending on the number of AIA Vitality Points you earn from exercising within that calendar month. Please see the table under "Qualifying AIA Vitality Points" for details.
- 1 reward credit can then be used to select only one of the reward partners available (based on your AIA Vitality Status at the point of converting your active reward). Reward partners may change from time to time, please refer to website www.aia.com.hk/aiavitality for the latest update.
- Terms and conditions apply when you use 1 reward credit to select 1 Green Common e-Shop e-Coupon. Please refer to section - Important Points to Remember.
- If you earn the maximum number of points for fitness-related activities (15,000 AIA Vitality Points) within a membership year, you will receive 2 reward credits each month for the rest of your current AIA Vitality membership year.

1,500 points within a calendar month	2 reward credits a month

Note: If you have earned the maximum number of points for fitness-related activities (15,000 AIA Vitality Points) within a membership year, you will receive 2 reward credits each month for the rest of your current AIA Vitality membership year.

[^]The fitness-related activities for earning AIA Vitality Points include:

- Pure Fitness or Pure Yoga gym visits (your membership must be linked to AIA Vitality)
- Organised fitness events (participating in an organised fitness event that qualifies for AIA Vitality Points)
- Fitness device workout data (recording a workout using a partner fitness device or AIA Connect Step Counter that you have linked to AIA Vitality)

Reward Credits and Green Common e-Shop e-Coupons



Step 1: Exercise and earn AIA Vitality Points to qualify

You will need to exercise and earn the required number of AIA Vitality Points to qualify for reward credits. You may also log in to AIA Connect app or website to check your reward credit balance and redeem them at any time. Don't forget that reward credits will expire in 3 months from the end of the month in which you earned the qualifying AIA Vitality Points, if you do not select the reward from your Wallet of AIA Connect. Please check your account balance regularly.

Step 2: Redeem reward credits on AIA Connect app or website

Log in to AIA Connect app or website, click on “Wallet” tag > “Rewards” tag > “Monthly Reward Credit” tag > select “Green Common e-Shop HK\$30 or HK\$50 e-Coupon” under “My Voucher”. You will see the number of reward credits you can select. You may select the number of reward credits to be redeemed as Green Common e-Shop e-Coupons. The redemption will automatically be applied to the reward credits expiring first.

The Green Common e-Shop e-Coupon will expire in 3 months starting from the end of the month in which the qualifying AIA Vitality Points were earned or upon the termination of AIA Vitality membership. No reminder will be sent to you. Please check your account balance regularly.

Note: Once you have chosen Green Common e-Shop e-Coupons, no exchange is allowed.

Step 3: Redeem your Green Common e-Shop e-Coupons
