 - b. The calculation of the premium discount is only applicable to the standard premium (extra premium due to underwriting (if any) is excluded) of the New Policy. The premiums of all other basic plan(s) and levy will not be applied for calculating the premium discount amount.
 - c. Each New Policy can only enjoy this promotional premium discount offer once during the Promotional Period. If the New Policy fulfils more than one promotional premium discount offer's requirement, the promotional offer with higher premium discount amount will be entitled.
 - d. In the event of full surrender of the New Policy within the first 3 policy years, the New Policy is not entitled to premium discount and accordingly AIA shall have the right to claw back the entire premium discount by deducting such amount from the Surrender Benefit payable.

In the event of partial surrender of the New Policy within the first 3 policy years, the New Policy is not entitled to the full amount of the premium discount and accordingly AIA shall have the right to claw back part of the premium discount by deducting such amount from the Surrender Benefit payable. The amount of the premium discount to be clawed back will be based on the percentage of reduction of the New Policy's Principal Amount caused by such partial surrender.
