

## AIA “Mega Lucky Draw - Your Prizes, Your Choice Campaign” Terms and Conditions

1. The AIA “Mega Lucky Draw - Your Prizes, Your Choice Campaign” (“Lucky Draw”) is organised by AIA International Limited, a company incorporated under the laws of Bermuda with limited liability (“AIA”). The campaign period is valid from 20 January 2023 at 9 a.m. to 28 February 2023 at 6 p.m. (“Campaign Period”). It is subject to Hong Kong time and the time received by the AIA's server. By participating in the Lucky Draw, the participants shall be deemed to have read, understood and agreed to be bound by these Terms and Conditions.
2. Participants, who fulfil the followings conditions (“Eligible Participant”), would enter the Lucky Draw.
  - 1) is a policyholder of AIA in-force individual insurance policy as selected by AIA; and

  - 3) policyholder only; and

  - 4) Entertainment (value of individual prize is around HK\$1K): Total value around HK\$50,000

    - ii. KLOOK Coupon
    - iii. OCEAN PARK General Admission Ticket x 2 Adults
  - 5) Leisure Coupon (value of individual prize is around HK\$800): Total value around HK\$40,000
    - i. LOG-ON Coupon
    - ii. LANE CRAWFORD Coupon
    - iii. MANNINGS Coupon
4. The value of prizes in each category may be slightly different and may be deviated from the market price. All the displayed values are for reference only. The prizes will be presented to winners in physical form and/or redemption letter.

5. Each Eligible Participant can join the Lucky Draw once and have one Lucky Draw chance only. Participants are entitled to 1 lucky draw chance even they have more than 1 valid individual insurance policy.
6. Each selected customer can participate in this lucky draw once (1 draw). For customers who have linked their AIA Connect account to a valid AIA in-force individual insurance policy, they are entitled to 1 more draw, adding up to 2 draws in total. Yet, each customer can only win and choose the prizes once.
