With effect from the Effective Date, as per the revised Code on Disclosure for MPF Investment Funds issued by the Mandatory Provident Fund Schemes Authority (the "MPFA"), the KSID will be available. The KSID will form part of the offering document of the Scheme. The KSID will help provide Members with key scheme information relating to the Scheme in a simplified and standardized format prescribed by the MPFA. That said, while the KSID could facilitate Members to obtain an overview of the key details and features of the Scheme, Members should not make investment decisions based solely on the KSID.

The introduction of the KSID would not result in any changes to the features of the Scheme and the contents of the constitutive documents of the Scheme.
