AIA Hong Kong Receives Coveted 'Capital Outstanding Green Excellence Award'

Hong Kong, 16 January 2014 – AIA Hong Kong was honoured for its green performance at the 'Capital Outstanding Green Excellence Awards 2013', making it the only financial or insurance institution to receive this recognition. The award is organised by renowned financial publication Capital Magazine.

Mr. Jacky Chan, Chief Executive Officer of AIA Hong Kong and Macau, said, "As Hong Kong citizens' real life partner, being a socially responsible corporation is an inherent part of our role. Understanding that environmental protection is a top global concern, AIA Hong Kong initiated our Environmentally Friendly Programme back as early as 2002 to advocate a 'go-green' culture among our employees and to create a better environment for the next generation. This award is a testament to our continued efforts to help sustain our environment. It motivates us to go the extra mile in doing what we believe is the right thing to do."

The AIA Environmentally Friendly Programme encourages its staff to embrace waste reduction both at work and home. By organising e-waste Collection Days, the Company calls upon its staff to donate used electrical devices to Caritas Hong Kong, where the recycled devices benefit underprivileged people in need. AIA Hong Kong supports Hong Kong Government's 'The Energy Saving Charter on Indoor Temperature' which aims at maintaining an average office indoor temperature of 24 - 26°C during the summer months. The Company adopts the use of energy-efficient lighting in place of incandescent light bulbs and encourages its staff to power off electronic equipment that is not in use before leaving the office and during lunch hours. In addition, AIA Group Limited has partnered with non-governmental organisation Food Angel since April 2013. The programme collects surplus food twice a week from AIA Central's banquet service to help nourish mainly elderly and underprivileged families.

Launched in 2009, the goal of the 'Capital Outstanding Green Excellence Awards' is to enhance the competitiveness of Hong Kong by promoting a greener business environment. The Awards recognise the contributions of Hong Kong enterprises in their continuous pursuit of a green economy. The theme for 2013, 'Joining Hands for a Green Economy', stresses the importance of collaboration and mutual support across all industries. An independent assessment panel, comprising the magazine's editorial board and high profile members of the community as well as of the business and environmental sectors, selected all the winners.
