#### Remarks:

- If the insured sustains any fracture, dislocation, internal injury or burn in an accident and suffers any of the covered injuries within 90 days after an accident, the Company will pay a lump-sum benefit according to the Benefits Schedule for Broken Bones And Major Injuries Benefit to help manage expenses.
- 2. The reimbursement benefit limit for Plan 1 of AIA Silvery Protect is up to HKD10,000 while the HKD20,000 benefit is only applicable to Plan 2 of AIA Silvery Protect.
