Interest on said loan will be at a rate to be determined by the Company but which shall in no case exceed the rate set out in the Loan Provisions of the Policy. The said interest shall be payable on the anniversary of the Policy in each year until said loan is repaid, and if interest on the loan is not paid when due it shall be added to the existing loan and shall bear interest at the same rate and on the same condition. If required by the Company, any unpaid premiums due and levy (for Hong Kong policies) before the next policy anniversary shall be paid out of this loan. If and when the total indebtedness on the Policy, including interest due or accrued, equals or exceeds the amount of the cash surrender value thereof at such time, then the Policy shall forthwith terminate and become void at the time and upon the conditions provided in the Policy for such contingency. 
