Removal of underlying fund for certain investment funds and the update of underlying fund details for all investment funds under AIA Macau Retirement Fund Services

Thank you for your continued support to AIA Macau Retirement Fund Services. As one of the leading pension service providers in Macau, we strive to strengthen our services and products in the best interests of our members.

The AIA Allianz Growth Fund is currently one of the underlying funds for the AIA Macau Capital Stable Fund, AIA Macau Balanced Fund, and AIA Macau Growth Fund (collectively, the "Relevant Investment Funds"). Due to the upcoming termination of the AIA Allianz Growth Fund, all assets held by the Relevant Investment Funds in the AIA Allianz Growth Fund was transferred to the AIA Growth Fund (an existing underlying fund of the Relevant Investment Funds) and subsequently the AIA Allianz Growth Fund will be removed as an underlying fund of the Relevant Investment Funds.

As at the effective date of the AIA Allianz Growth Fund's termination, the AIA Growth Fund will invest in the same underlying fund that the AIA Allianz Growth Fund is currently investing in.
