Re: Application of Employment Support Scheme (the "ESS")

## **Background**

In response to the severe blow dealt by the COVID-19 epidemic to economic activities in Hong Kong, the Government of the Hong Kong Special Administrative Region (the "HKSARG") has launched the ESS to help the corporations to stay afloat, and assist the economy to recover once the epidemic is contained.

### **ESS's Subsidy**

All employers who have been making Mandatory Provident Fund (MPF) contributions for their employees may be eligible for applying the government subsidy (except the HKSARG, statutory bodies and subvented staff in Government funded organizations, etc.).

Wage subsidies for each employer will be calculated on 50% of actual wages at a "specified month" (capped at a wage of HK\$18,000 per month) payable for 6 months, which will be disbursed to employers in two tranches, with the first before end of June 2020 and the second is expected in September 2020<sup>1</sup>. The maximum wage subsidy per employee is HK\$9,000 per month. In the first tranche, you may choose <u>any one of the four months from December 2019 to March 2020</u> as the "specified month", taking into account of your company's own circumstances.

# Am I Eligible for the ESS's Subsidy for the 1st tranche?

You must fulfill the following criteria(s):

- 1) Your MPF account should have been already set up with us as at 31 March 2020; and
- 2) Employers may only apply for wage subsidies in respect of employees for whom mandatory contributions for the specified month have been settled in full on or before 7 May 2020.

## How about the 2<sup>nd</sup> tranche subsidy?

Discussion among MPF industry and the HKSARG is in progress, we will provide further details to you shortly.

# How and When to Apply for the 1st tranche subsidy?

The application process is as follows:

Step 1: You may choose <u>any one of the four months from December 2019 to March 2020</u> as the "specified month" for your ESS's application provided that you have met the above-mentioned

criteria.

Step 2: A HKSARG portal<sup>2</sup> will be set up for online application for ESS which will be in operation from <u>25</u>

May 2020 to 14 June 2020. Please submit the ESS application form via the HKSARG portal during the said application period.

Step 3: Upon receipt of your application, ESS processing agent will request us to provide your MPF scheme information, including but not limited to (i) number of employees and employer's contribution amount, and (ii) the Relevant Income of each employees in the "specified month" for calculating the amount of ESS subsidy.

- (1) view your contribution information from December 2019 to March 2020 to facilitate your selection of "specific month" before submitting your ESS's application; and
- (2) download an MPF record certificate summarizing the information we provided to ESS processing agent for reference.
